Councillor Mrs Ann Kennedy stated that she did not have any pecuniary interest when the Newry Beach shelters were discussed in respect of the involvement of Môn CF. Councillor Trefor Lloyd Hughes MBE also stated that he did not now have any involvement regarding the Landtrain.

4. MAYOR' S ANNOUNCEMENTS:

Councillor Richard Parry, from the chair stated that he did not have anything to report from the Mayor. He did, however, state that a meeting had been held on Friday, 4th September 2020, with Virginia Crosbie the MP for Ynys Môn and the topics discussed were Wylfa B, Jobs at RAF Valley, MINESTO and the building of a new Medical Centre for the town.

6. To approve the Minutes of the Finance & General Purposes Committee meeting held on the 20th July 2020 by remote.

Councillor Keith R Roberts confirmed that he, as Chairman had chaired the meeting.

Councillor Trefor Lloyd Hughes MBE commented that should the Town Clerk be on annual leave that the Staffing Committee had already resolved that the Deputy Clerk should be at work so that two officers were not absent from the office at the same time.

7. PROPOSAL REGARDING THE SHELTERS AT THE NEWRY BEACH:

The Town Clerk confirmed that an initial discussion had been held between himself and representatives of Môn CF as the Holyhead Town Council were not able to obtain grant funding to up-grade/re-furbish any of the shelters (there were 4 in total). Councillors voiced their concern that they had not been in attendance at the initial meeting and were not aware of what had already been discussed. The Town Clerk, as an officer of the Council re-iterated that he had always been given authority, on behalf of the Council to progress any business and this would be made available to Council members at meetings once any discussions had taken place. The Town Clerk confirmed that a public consultation would be held if any proposals on the shelters at the Newry Beach were to be progressed and grant funding applied for in the future.

It was resolved, proposed and seconded that the Town Clerk contact Conygar to ask if they were prepared to fund any up-grade or refurbishment costs and that it was a good idea for a tri-party partnership to be formed in the future consisting of Holyhead Town Council/Conygar and Môn CF as the up-grading of these shelters would be an asset to that area of the town.

Councillor W J Chorlton abstained from voting on this matter.

The members of the Town Council asked if a detailed presentation could be made by both Môn CF and the Town Clerk in the near future and the Town Clerk confirmed that an Extra – Ordinary meeting would be held as the deadline for any grant funding applied for was October 2020.
